**ORDER**

---

**UPON** hearing counsel for the parties at a hearing dated 18 July 2005 on the questions of costs and, in case 1022/1/1/03, permission to appeal in the above proceedings

**AND UPON** the Tribunal handing down its judgments in relation to costs and permission to appeal on 19 July 2005 ([2005] CAT 26 and [2005] CAT 27 respectively)

**AND UPON** considering JJB Sports PLC's ("JJB") written submissions in reply to the Respondent's application for costs relating to JJB's request for permission to appeal

**IT IS ORDERED THAT:**

1. In respect of cases 1021/1/1/03 and 1022/1/1/03, Allsports Limited ("Allsports") and JJB Sports ("JJB") shall pay 35% and 40% of the Respondent's total costs relating to liability, subject to paragraph 2.
2. Allsports shall pay 50% of the Respondent's costs relating to the application for summary judgment dated 12 January 2004.
3. JJB shall pay the Respondent's costs in relation to its request for permission to appeal from the Tribunal's decisions in relation to liability and penalty.
4. Such costs be subject to summary or detailed assessment, as the Tribunal may direct, pursuant to Rule 55(3) of the Competition Appeal Tribunal Rules 2003 (S.I. 1372 of 2003) if not agreed within 28 days.
5. Sports World International Limited's ("SWI") application for costs be adjourned to a date to be fixed, if necessary.
6. SWI shall within 21 days prepare a schedule of costs with a supporting note, to be served on Allsports and JJB. Allsports and JJB shall within 14 days serve any observations thereon. The Tribunal will then give such directions as may be necessary for the further determination of the matter.
7. The question of the costs in relation to SWI's application for costs be reserved until further order.
8. Save as aforesaid, there be no order as to costs.
9. JJB's request for permission to appeal from the Tribunal's decisions in relation to liability and penalty be refused.
10. Liberty to apply.
