- 1 THE PRESIDENT: Good afternoon.
- 2 MR. FLYNN: Good afternoon, Sir. The last few hours have been productive from our point of
- 3 view. Sir, have you been given a piece of paper?
- 4 THE PRESIDENT: I have.
- 5 MR. FLYNN: This is a draft order which represents something to which I will not say everyone
- 6 is "happy", that might not be the right word everyone is committed to.
- 7 THE PRESIDENT: Sufficiently not unhappy!
- 8 MR. FLYNN: Sufficiently not unhappy! Would it assist you if I were to take you through it, Sir?
- 9 THE PRESIDENT: I have read it. I assume on these occasions the less I have to say the better,
- and I have not got anything to say of substance. I just have a couple of quick points on it.
- One is whether it would be sensible to say, perhaps in the last recital, "And upon [whoever
- it is] agreeing to the terms of the order". There is nothing to indicate that. I think one can
- imply it because there are undertakings by both groups, as it were. If that has not been left
- out because of some ----
- MR. FLYNN: There is no outstanding agreement. Everyone has agreed, we are not waiting for
- anyone.
- 17 THE PRESIDENT: Could I therefore suggest that the final recital says, "And upon", is it "all the
- parties", or "upon the parties agreeing to the terms of this order"?
- 19 MR. FLYNN: I suppose I would question the position of the Premier League and Orange.
- 20 THE PRESIDENT: "And upon", and their names.
- 21 MR. FLYNN: Then it would be Sky, the three front interveners and Ofcom, if I can put it that
- 22 way.
- 23 | THE PRESIDENT: If that is not going to put the cat among the pigeons then I think that would
- be quite a good thing to add.
- 25 MR. FLYNN: Speaking for Sky, it certainly would not put the cat among the pigeons from our
- point of view.
- 27 | THE PRESIDENT: The only other point I have is just in para.1 of the substantive part of the
- order. "Subject to the other conditions of this order and the attached schedule", I was not
- sure, was that just a reference to the undertakings?
- 30 MR. FLYNN: I think it is, Sir, yes. I think that is right.
- 31 THE PRESIDENT: I think it might be better just to say, "Subject to the above undertakings and
- 32 the terms of this order".
- 33 MR. FLYNN: Yes, I think that must be right, because apart from the undertakings and the
- schedule, the only other thing in the order is the liberty to apply. I think that must be right.

1	THE PRESIDENT: It might be better, otherwise it might confuse the reader, the easily confused
2	reader like me. Apart from that there is the odd typo.
3	MR. FLYNN: Yes. I will not bore you with the ones that we have collectively picked up in the
4	last few minutes, but we will convey those to the Registrar.
5	THE PRESIDENT: You probably want that order made as soon as possible, do you not?
6	MR. FLYNN: As soon as may be, Sir. We will have a word on the tidying up now, I imagine,
7	and then it will be for you to make the order at your convenience.
8	THE PRESIDENT: I will do that today, if it can be tidied up fairly quickly. I am sure, if you
9	agree the tidying up, we can make the order. Have we got this electronically on our
10	system?
11	MR. FLYNN: Yes, you have.
12	THE PRESIDENT: In which case, we can do that very quickly. In fact, before people leave, if
13	they could feed in their typos and other little changes and agree them then that can be done.
