ORDER

UPON the Court of Appeal's judgment of 17 February 2014 ([2014] EWCA Civ 133) and subsequent order dated 28 February 2014 (as amended) setting aside the Tribunal's Orders dated 6 March 2013 and 17 May 2013 and remitting the matter to the Tribunal for further consideration (the Remittal)

AND UPON the Tribunal listing a case management conference for 3 December 2015

AND UPON having been informed that four interveners, Top Up TV Europe Limited, Freesat (UK) Limited, The Rugby Football Union and The Football Association Limited wish to take no part in the proceedings concerning the Remittal

IT IS ORDERED THAT:

- 1. By 5pm on 6 November 2015:
 - (a) if so advised, the Appellants and the Respondent file and serve an outline of the grounds (or parts of grounds) and any supporting evidence on which they expect to rely in the context of the Remittal proceedings, with cross references to the pleadings and evidence that has already been filed; such shall identify any grounds or issues that the party considers are likely to fall for determination by the Tribunal in the event that the Tribunal finds either for or against the Respondent on the remitted matter;
 - (b) if so advised, the parties file and serve any application for the admission of new evidence, being evidence not before the Tribunal in the original proceedings in these cases, with an indication of the nature of that evidence and the reasons why the Tribunal should admit it;
 - (c) if so advised, the parties file and serve any other applications they wish to make in the proceedings and/or any written submissions on case management issues;
- 2. By 5pm on 20 November 2015, the parties, if so advised, file and serve responsive submissions in respect of 1 (a)-(c) above
- 3. By 5pm on 27 November 2015 the parties file and serve any skeleton arguments for the case management conference listed for 3 December 2015
