#### ORDER OF THE CHAIRMAN

**UPON** reading the correspondence from the Claimant dated 24 February 2012

### IT IS ORDERED THAT:

- 1. The Claimant's request that the Tribunal issue a witness summons ("the Summonses") to each of the following witnesses be granted:
  - a. Mr David Beverley Fowles (Managing Director of 2 Travel);
  - b. Mr Nigel Vernon Short (Director and Shareholder of 2 Travel);
  - c. Mr David Huw Francis (Director and Shareholder of 2 Travel);
  - d. Mr David Rhys Fowles (Operations Director of 2 Travel);
  - e. Mr Graham Donald Cartwright (Cardiff Traffic Manager of 2 Travel);
  - f. Mr Charles Hugh Jones (Llanelli Traffic Manager of 2 Travel);
  - g. Mr Christopher Sutton (Jones Lang LaSalle);
  - h. Mr Jeffrey Roger Durbin (South Gloucester Bus and Coach Company);
  - i. Mr Clayton Francis Jones (Heart of Wales Bus & Coach Company); and
  - j. Mr Daniel Conway (BDO LLP),

("the Witnesses").

2. The Summonses will provide for the attendance of the Witnesses in question throughout the anticipated dates of the hearing (i.e. from 12 March 2012 for

- two weeks). In due course, the Claimant shall in consultation with the Defendant and the Tribunal identify the specific dates when the attendance of the Witnesses will be required and shall keep the Witnesses so informed.
- 3. Pursuant to rule 63(3) of the Competition Appeal Tribunal Rules 2003 (S.I. No. 1372 of 2003) ("the Tribunal Rules") the Summonses and a copy of this Order shall be served on each of the Witnesses by Addleshaw Goddard LLP, the Claimant's solicitors, by post using the Royal Mail's 'Special Delivery' service. The Summonses shall be treated as having been served on 1 March 2012.
- 4. The Claimant shall pay to the Witnesses the sum referred to in rule 23(3)(b) of the Tribunal Rules being:
  - a. sufficient to cover their travelling expenses to and from the Tribunal and for loss of time; and
  - b. such additional sum (if any) as would be recoverable by the Witnesses in respect of their attendance in proceedings before the Senior Courts of England and Wales.
