- 8. A pre-trial review be listed on a date to be fixed between 5 and 12 June 2018 (inclusive).
- 9. Viasat shall file and serve its skeleton argument by 4pm on 12 June 2018.
- 10. Of com and Inmarsat shall file and serve their skeleton arguments by 4pm on 19 June 2018.
- 11. Six copies of the bundles of authorities shall be prepared by the parties and lodged at the Tribunal by 4pm on 21 June 2018.
- 12. The main hearing of the appeal to be listed for four days namely the 26, 27, 28 June and 3 July 2018 (inclusive).
- 13. All parties to file their written closing submissions by 4pm on 29 June 2018.
