**UPON** considering HCA International Limited's ("HCA") application of 17 October 2014 to:

- (i) amend its Notice of Application in the form of the amended Notice of Application enclosed with its application (the "Amended Notice of Application");
- (ii) adduce a factual report by KPMG (the "KPMG Report"); and
- (iii) adduce an expert report of Professor Michael Waterson (the "Waterson Report")

**AND UPON** considering the Respondent's observations on HCA's application

**AND UPON** considering letters in relation to the timetable in these proceedings from: (i) the Respondent dated 22 and 24 October 2014; (ii) HCA dated 23 October 2014; and (iii) AXA PPP Healthcare Limited ("AXA") dated 23 October 2014

**IT IS ORDERED THAT:**

1. HCA's application to amend its Notice of Application in the form of the Amended Notice of Application be granted
2. HCA's application to adduce the KPMG Report be granted
3. HCA's application to adduce the Waterson Report be considered at the main hearing in these proceedings
4. The Respondent file and serve its amended Defence to the Amended Notice of Application by 4pm on 14 November 2014
5. HCA file and serve its skeleton argument, incorporating any submissions in reply to the amended Defence, by 4pm on 10 December 2014
6. AXA and the Federation of Independent Practitioner Organisations file and serve their skeleton arguments by 4pm on 10 December 2014
7. The Interveners in support of AXA file and serve their skeleton arguments by 4pm on 12 December 2014
8. The Respondent file and serve its skeleton argument by 4pm on 24 December 2014
9. The Interveners in support of the Respondent file and serve their skeleton arguments by 4pm on 7 January 2015
10. The parties file six copies of an agreed bundle of documents to serve as the core bundle for the main hearing, together with six copies of an agreed joint bundle of authorities to be referred to at the main hearing, by 4pm on 12 January 2015

11. There be liberty to apply
