HAVING REGARD TO the Tribunal's Order drawn on 19 December 2018 (the "Order")

AND HAVING REGARD TO the Tribunal's powers under the Competition Appeal Tribunal Rules 2015

AND UPON reading the letter of Hausfeld & Co. LLP dated 28 February 2019, sent on behalf of the Claimants, applying to vary the time period for responding to paragraphs 5, 6 and 7 of the Order and the letter of Travers Smith LLP of the same date confirming the Defendants' consent

IT IS ORDERED BY CONSENT THAT:

1. The deadline for the Claimants to circulate draft amendments to their Particulars of Claim (insofar as they wish to do so) in accordance with paragraph 5 of the Order is varied to 4pm on 15 March 2019.
2. The deadline for the Defendants to confirm whether they consent to those amendments in accordance with paragraph 6 of the Order is varied to 5 April 2019 (or within 21 days of receipt of the Claimants' draft amendments, if earlier).
3. The deadline for the Claimants to make any application to the Tribunal for permission to amend their Particulars of Claim (to the extent the Defendants do not consent to the amendments sought) in accordance with paragraph 7 of the Order is varied to 12 April 2019 (or within 7 days of receipt of all the Defendants confirmations under paragraph 6 of the Order, if earlier).

5. There be liberty to apply.
