addition to the Respondent's own pleadings, submissions and evidence).

4. The Respondent shall, if so advised, file and serve any evidence from Tesco on which it intends to rely

by 5pm on Monday 8 April 2019.

5. The Applicant shall, if so advised, file and serve its Reply to the Respondent's Defence by 5pm on

Monday 8 April 2019.

6. The parties shall agree any supplementary hearing bundle to be lodged by the Applicant by 5pm on

Monday 15 April 2019.

7. The Applicant shall file and serve its skeleton argument and, if so advised, any evidence in reply to any

evidence filed in accordance with paragraph 4 above by 5pm on Tuesday 30 April 2019.

8. The Respondent shall file and serve its skeleton argument by 5pm on Tuesday 7 May 2019.

9. The Applicant shall file an agreed bundle of authorities and an agreed indicative timetable for the

hearing by 5pm on Friday 10 May 2019.
