**CONSENT ORDER**

---

**UPON** the Tenth and Eleventh Defendants' (the "**Daimler Defendants**") application dated 1 April 2020 to extend until 1 May 2020 the time for the Daimler Defendants to disclose certain documents responsive to paragraph 5(c) of the Order of the Tribunal

drawn on 26 November 2019 (“**Order**”) (the “**Remaining Categories**”, as more precisely defined below).

**AND UPON** the Claimants and the Daimler Defendants having previously agreed to an extension until 3 April 2020 of the deadline for the Daimler Defendants to disclose documents responsive to paragraph 5(c) of the Order.

**AND UPON** the Claimants and the Daimler Defendants having agreed due to the unprecedented circumstances arising from the Covid-19 pandemic to extend until 1 May 2020 the time for the Daimler Defendants to disclose the Remaining Categories.

**AND UPON** the following definition applying for the purposes of this Order:

- the “**Remaining Categories**” means hard copy documents responsive to category O3, exchange rate documents responsive to category O18, meeting minutes and supporting documents of the Executive Committee of the Mercedes-Benz Truck Unit responsive to categories O2, O3 and O4A identified in the Order.

**IT IS ORDERED BY CONSENT THAT:**

1. The deadline for the Daimler Defendants to provide disclosure to the Claimants of the Remaining Categories shall be further extended to 1 May 2020.
2. The parties have liberty to apply.
