**CONSENT ORDER**

---

**UPON** the Order of the Tribunal made in these proceedings on 19-20 September 2019 (the “**Disclosure Order**”), in particular paragraph 6(b), which directed Volvo/Renault to disclose by list documents and/or data responsive to the O4A, DG O1, DG O2, DG

O3, DG O4B, DG O4C, DG O5D and DG O6 categories identified in Annex 3 to that Order

**AND UPON** the Consent Order made on 6 March 2020 ordering that Volvo/Renault's disclosure of the documents referred to in paragraph 6(b) of the Disclosure Order be extended to 30 April 2020

**AND UPON** the Consent Order made on 27 April 2020 ordering that Volvo/Renault's disclosure of the documents referred to in paragraph 6(b) of the Disclosure Order be further extended to 4 June 2020

**AND UPON** the Consent Order made on 2 June 2020 (the "**2 June Extension Order**") ordering that Volvo/Renault's disclosure of the documents in respect of the Remaining Categories (as defined in the 2 June Extension Order) be further extended to 10 July 2020

**AND UPON** the application by Volvo/Renault by their solicitors' letter dated 8 July 2020 further to extend the time for certain disclosure by reason of the difficulties caused by the Covid-19 pandemic, which application is agreed to by the Claimants

**AND UPON** the definitions adopted in the Disclosure Order and the 2 June Extension Order applying for the purposes of this Order

**BY CONSENT IT IS ORDERED THAT:**

1. The time for Volvo/Renault's disclosure of data/documents referred to in paragraph 6(b) of the Disclosure Order responsive to category DG O4C of Annex 3 to the Disclosure Order be extended to 31 July 2020.
2. Costs in the case.
3. There be liberty to apply.
