CONSENT ORDER

UPON the Claimants and First to Sixth Defendants (the "**DAF Defendants**") and the Twelfth to Sixteenth Defendants (the "**Volvo/Renault Defendants**") agreeing to extend to 14 August 2020 the deadline for the filing and service of the DAF Defendants' Defence and the Volvo/Renault Defendants' Defence;

AND UPON that agreement being conditional on the extension not delaying the transfer of these proceedings to the Competition Appeal Tribunal (the "**Tribunal**"), provided for under the order of Master Clark made on 3 February 2020 (the "**Transfer Order**");

AND UPON paragraph 2 of the Transfer Order providing that the Claim shall be transferred to the Tribunal "*upon the earlier of: (a) the service and filing of any Replies; or (b) 28 days following the service and filing of Defences.*"

AND UPON the parties having agreed to the terms of this consent order

BY CONSENT IT IS ORDERED THAT:

1. The time for the Volvo/Renault Defendants and the DAF Defendants to file and serve their respective Defences to the Claim be extended to 14 August 2020.
2. Paragraph 2 of the Transfer Order be varied so that it reads: "*The provisions at paragraph 1 of this order shall take effect on 7 August 2020*".
3. Costs in the case.
4. The DAF Defendants shall serve this order on the parties.
