**UPON** the Defendants' application dated 11 February 2022 for a direction that the Claimants clarify five matters which the Defendants say are relevant to the selection of frontrunner/test claimants in the above proceedings (the "Second Application")

**AND UPON** the Tribunal writing to the Claimants and Defendants on 17 February 2022 in relation to the Second Application (the "Tribunal Letter")

**AND UPON** reading the letters from the Claimants and the Defendants of 21 February 2022 in response to the Tribunal Letter

**AND UPON** a case management conference being listed for 3 and 4 March 2022

**IT IS ORDERED THAT:**

1. By 2pm on 28 February 2022, the Claimants shall provide a disclosure statement:
  - (a) Confirming whether C83 in the Veolia proceedings holds documents that are relevant to C87.
  - (b) Specifying the number of the trucks acquired by C226 from C246 in the Suez proceedings, during the relevant period.
  - (c) Specifying the number of the trucks acquired by C226 from C229 in the Suez proceedings, during the relevant period.
  - (d) Confirming whether C53 in the Suez proceedings holds documents that are relevant to C97.
  - (e) Explaining, in brief terms only, the basis of the claims brought by C28-30, C33-42, C43-49, C51, C54, C56, C74, C116, C118, C127 and C128 in the Wolseley Proceedings and how they relate to the claims of C26, C27 and/or C50.
2. Costs in the case.
3. Liberty to apply.
