BY CONSENT IT IS ORDERED THAT:

1. The time for service of claim forms in the Scott+Scott Interchange Fee Proceedings be

extended until 28 October 2022, except that the extension may be terminated in respect of

either of the Scott+Scott Interchange Fee Proceedings listed in the Schedule to this Order

at any time by either the Claimants or the Defendants giving 30 days' written notice to the

other party.

2. The claim forms shall be served in accordance with the Civil Procedure Rules 1998

("CPR") and the Tribunal's letter of 19 May 2022.

3. The time for any application pursuant to CPR 17.2(2) shall also be extended such that the

Defendants will have 14 days to make such an application which shall run from either the

date of service of the last claim form, or 28 October 2022 whichever is earlier.

4. There shall be liberty to apply.
