ORDER

UPON the separate applications made by the Claimants and the First Defendant in the Sportradar Claim on 17 May 2022 in respect of a document known as "FDC-775" disclosed by the First Defendant to the Claimants and the Second and Third Defendants in the Sportradar Claim (together, the "Applications")

AND UPON the Second and Third Defendants in the Sportradar Claim supporting the application made by the First Defendant in respect of FDC-775

AND UPON the Tribunal's ruling of 1 July 2022 ([2022] CAT 29) finding in favour of the Defendants in the Sportradar Claim that FDC-775 is subject to without prejudice privilege

AND UPON the agreement reached on 22 July 2022 between the Claimants and the First Defendant in the Sportradar Claim on the quantum of the First Defendant's costs of the Applications

AND UPON the agreement reached on 22 July 2022 between the Claimants and the Second

and Third Defendants in the Sportradar Claim on the quantum of the Second and Third

Defendants' costs of the Applications

IT IS ORDERED BY CONSENT THAT:

1. The Claimants in the Sportradar Claim shall pay the First, Second and Third

Defendants' costs of and occasioned by the Applications.

2. The First Defendants' costs agreed in the sum of £50,000 shall be paid by the Claimants

in the Sportradar Claim by 5pm on 5 August 2022.

3. The Second and Third Defendants' costs agreed in the sum of £35,305.56 shall be paid

by the Claimants in the Sportradar Claim by 5pm on 5 August 2022.
