ORDER

UPON the Order of the Honourable Mrs Justice Cockerill made on 14 June 2021, as amended by the Orders of the Honourable Mr Justice Butcher made on 18 March 2022, 10 and 21 June 2022 and 2 August 2022 (the "**Directions Order**")

AND UPON the parties agreeing by consent to extend the timetable for the service of (i) factual evidence on behalf of the Mastercard Defendants; (ii) evidence in reply on behalf of the Claimants; and (iii) certain expert evidence on behalf of all parties.

AND UPON the letter from the solicitors for the Mastercard Defendants to the Tribunal dated 9 September 2022 requesting amendments to the Directions Order to extend the timetable for service of factual evidence on behalf of the Mastercard Defendants, factual evidence in reply on behalf of the Claimants and certain expert evidence on behalf of all parties.

IT IS ORDERED BY CONSENT THAT:

- 1. Paragraphs 4 to 5 of the Directions Order are varied such that the deadlines for filing and service of factual evidence shall be as follows:
 - (a) The Mastercard Defendants shall file and serve signed statements of witnesses of fact, and hearsay notices where required by CPR rule 33.2, by 4pm on 23 September 2022.
 - (b) The Claimants shall file and serve signed reply statements of witnesses of fact, and hearsay notices where required by CPR rule 33.2, by 4pm on 22 November 2022.
- 2. Paragraphs 7 to 10 of the Directions Order are varied such that the deadlines for filing and service of expert evidence for the parties' economic and forensic accounting experts, and the Mastercard and Visa Defendants' ATM industry experts, shall be as follows:
 - (a) The Claimants shall file and serve signed expert reports on the Defendants by 4pm on 1 December 2022.
 - (b) The Mastercard Defendants and the Visa Defendants shall each file and serve signed expert reports on the Claimants by 4pm on 24 February 2023.

- (c) The Claimants shall file and serve signed supplemental expert reports on the Defendants by 4pm on 28 April 2023.
- (d) The parties' experts in each of the disciplines named at paragraph 2 of this Order shall meet to discuss their respective reports by no later than 19 May 2023 and shall produce joint statements of matters agreed and not agreed that shall be served by 4pm on 16 June 2023.
- 3. The deadlines for expert evidence for the parties' foreign law experts will remain as originally set out at paragraphs 7 to 10 of the Directions Order, and such expert evidence shall be filed as well as served by the relevant deadlines.
