CONSENT ORDER

UPON the Claimants and the Fifth to Ninth Defendants no longer being in dispute with each other regarding the subject matter of these Proceedings (the "**Resolution**")

AND UPON the Resolution having no effect on the Claimants' ability to pursue the proceedings against the Tenth and Eleventh and Seventeenth to Twentieth Defendants subject to a carve out in respect of the Fifth to Ninth Defendants' group's share of alleged liability and the Claimants having expressly reserved their rights to do so

BY CONSENT IT IS ORDERED THAT:

1. The proceedings against the Fifth to Ninth Defendants be stayed except for the purpose of carrying the confidential terms of the Resolution into effect and, for that purpose, the Claimants and the Fifth to Ninth Defendants have permission to apply without the need to issue fresh proceedings.
2. This stay shall apply to all directions in outstanding Tribunal Orders in the proceedings as between the Claimants and the Fifth to Ninth Defendants, including, for the avoidance of doubt, the Orders made on 22 July 2021 and 20 September 2022.
3. There shall be no order as to costs.
