ORDER

UPON reading the application from Stephenson Harwood LLP by letter dated 13 October 2022 for an extension of time for service pursuant to Rule 53(2)(j) of the Competition Appeal Tribunal Rules 2015 in respect of the proceedings listed in the Schedule to this Order (the "Proceedings"), which were issued in the High Court and are now proceeding in the Competition Appeal Tribunal but which have yet to be served ("the Application")

AND UPON reading the letter dated 17 October 2022 from Linklaters LLP for the Visa

Defendants in these Proceedings confirming that they do not object to the Application

IT IS ORDERED THAT:

1. The time for service of the claim forms in the Proceedings be extended until 30

November 2022.

2. The claim forms shall be served in accordance with the Civil Procedure Rules 1998

("CPR") and the Tribunal's letter of 19 May 2022.

3. The claim forms may be amended prior to service without the Tribunal's permission

pursuant to CPR 17.1(1).

4. The time for any application pursuant to CPR 17.2(2) shall also be extended such that

the Interchange Fee Defendants will have 14 days to make such an application which

shall run from either the date of service of the last claim form, there being two

respective dates for each of the Mastercard Claims and Visa Claims as listed in the

Schedule to this Order, or 30 November 2022, whichever is earlier.

5. There shall be liberty to apply.
