AND UPON the transfer of the Proceedings (filed at the High Court under CP-2021-000021) from the High Court of Justice to the Competition Appeal Tribunal pursuant to an Order of the Chancellor of the High Court dated 27 July 2022

AND HAVING REGARD TO rules 32(1)(a) and 44(1)(a) of the Competition Appeal Tribunal Rules 2015

BY CONSENT IT IS ORDERED THAT:

1. The claims brought by the Specialist Cars Group in these Proceedings against the Defendants are hereby withdrawn, and the Claim Form shall be amended by the Claimants to remove the Specialist Cars Group entities.
