and exchange expert reports by 4pm on 11 May 2023".

4. Paragraph 14 of the First Directions Order is amended to read: "Any expert reports in

reply shall be filed and served by 4pm on 29 June 2023".

5. Paragraph 15 of the First Directions Order is amended to read: "The experts shall meet

to discuss the expert reports by 27 July 2023 and shall file and serve a joint expert

report by no later than 4pm on 15 September 2023".

6. Paragraph 17 of the First Directions Order is amended to read: "By no later than 14

days after the outcome of the US Proceedings, the parties are to attend on the CAT

Registry to fix (i) a Pre-Trial Review; and (ii) the date for trial which shall not be before

[27 November 2023]".

7. Paragraph 18 of the First Directions Order is amended to read: "The Claimants shall

file and serve their written openings by 4pm on 27 October 2023. The Defendants shall

file and serve their written openings by 4pm on 10 November 2023".

8. Paragraph 8 of the Second Directions Order is amended to read: "The CMA shall file

and serve its written observations pursuant to Rule 50(2) of the Tribunal Rules by 5pm

on 8 September 2023".

9. Paragraph 9 of the Second Directions Order is amended to read: "If so advised, parties

file and serve written observations on the CMA's written observations by 5pm on 6

October 2023".

10. No order as to costs.

11. There shall be liberty to apply.
