required by Rule 35(3) of the Tribunal Rules). This is without prejudice to that the

Tribunal may, on its own motion and or upon the application of any Party, require the

production of these documents in the course of proceedings if it considers appropriate.

It is also without prejudice to the Claimants' right to request disclosure of documents

pursuant to Rule 61 of the Tribunal Rules.

2. There shall be no order as to costs.

3. There shall be liberty to apply.
