## BY CONSENT IT IS ORDERED THAT:

- The time for the Volvo/Renault Defendants (being Aktiebolaget Volvo (Publ), Volvo Lastvagnar Aktiebolag, Volvo Group Trucks Central Europe GMBH, Renault Trucks SAS and Renault Truck Commercials Limited) to comply with paragraph 11 of the Directions Order be extended to 4pm on 26 May 2023, in respect of the filing of one of its factual witness statements.
- The time for the Daimler Defendant (being the Tenth Named Third Party in the Wolseley Proceedings) to comply with paragraph 11 of the Directions Order be extended to 4pm on 26 May 2023, in respect of the filing of one of its factual witness statements.

- 3. All other factual evidence currently due to be filed by the Volvo/Renault Defendants and the Daimler Defendant by 4pm on 5 May 2023 is not subject to an extension.
- 4. Costs in the case.
- 5. Liberty to apply.
