Forum

1. The application be treated as proceedings in England and Wales for the purposes of Rule 18 of the Tribunal Rules.

Intervention

2. TMG is granted permission to intervene in the proceedings.

Confidentiality

3. A confidentiality ring be established by separate order in terms to be agreed by the parties.

- 6. The First Witness Statement of Mr Jonny Franklin-Adams dated 21 April 2023 be excluded.

- 8. The Applicants shall file any Reply, if so advised, by **5pm** on **30 May 2023**.
- 9. TMG shall file its Statement of Intervention by **5pm** on **30 May 2023**.
- The Respondent has permission to file expert evidence of Canadian law in response to Soliman 1. The Respondent shall, if so advised, file any such evidence by 5pm on 30 May 2023.
- 11. The parties shall inform each other (copied to the Tribunal) of any decisions of foreign competition authorities and/or courts upon which they intend to rely by **5pm** on **30 May 2023**.

- 12. The Applicants and Respondent shall, if so advised, file their Replies to TMG's Statement of Intervention by **5pm** on **2 June 2023**.
- 13. The Applicants shall lodge six hard copies and an electronic copy of an agreed hearing bundle by **5pm** on **7 June 2023**.
- 14. The Applicants shall file their skeleton argument by **5pm** on **9 June 2023**.
- 15. The Respondent shall file and serve its skeleton argument by **5pm** on **15 June 2023**.
- 16. TMG shall file and serve its skeleton argument by **midday** on **20 June 2023**.
- 17. The Applicants shall lodge six hard copies and an electronic copy of an agreed bundle of authorities by **5pm** on **21 June**.
- 18. The substantive hearing be listed for **26 and 27 June 2023** with a time estimate of two days.
