## ORDER

**AND UPON** the further Order of the Tribunal made on 20 November 2023 varying the Directions to Trial Order

**AND UPON** the parties to the *McLaren* Proceedings requesting a further extension to certain deadlines in the Directions to Trial Order (as amended) by letter dated 25 January 2024

#### **IT IS ORDERED THAT:**

- The case management conference in these proceedings fixed for 5 March 2024 be vacated. The case management conference shall be refixed for the first available date after 10 April 2022 and the parties shall liaise and provide convenient dates to the Tribunal.

- 4. Paragraph 14(b) of the Directions to Trial Order be varied so that the Receiving Party shall comply with the Disclosure Request in respect of the *McLaren* Negative Position Statements by no later than 4pm on 16 May 2024, unless otherwise agreed or directed.
- Paragraph 2 of the Directions to Trial Order shall be varied so that the *McLaren* Negative Position Statements shall be filed and served by 4pm on 28 June 2024.
- 6. The second case management conference, currently listed for 25 to 26 June 2024, shall be vacated. The second case management conference shall be refixed for the first available date after 28 June 2024 and the parties shall liaise and provide convenient dates to the Tribunal.
- 7. The parties have leave to apply generally.
- 8. Costs in the case.
