**CONSENT ORDER**

---

**UPON** the Order of The Honourable Lord Richardson made on 20 November 2023 and corrected on 24 November 2023 (the **Order**) requiring the parties to disclose the categories of documents set out in Annexes A – C to the Order by 4pm on 2 February 2024

**AND UPON** the Order of The Honourable Lord Richardson made on 29 January 2024 extending the period of time for the Claimants and the Defendants (the "**Parties**") to provide the Disclosure by 4pm on 16 February 2024

**AND UPON** the Parties now having agreed to a further 14-day extension of time for both the Claimants and the Defendants in case 1581/5/7/23 (the "**Utilita/PayPoint Proceedings**") to provide the Disclosure

**AND UPON** the Parties now having agreed to a further 5-day extension of time for both the Claimants and the Defendants in case 1597/5/7/23 (the "**Global-365/PayPoint Proceedings**") to provide the Disclosure

**BY CONSENT IT IS ORDERED THAT:**

1. Paragraph 15 of the Order shall be replaced in its entirety with the following:

“Further disclosure shall be provided as follows:

(a) By 4 p.m. on 21 February 2024:

- (i) the Defendants shall disclose the categories of documents set out in Annex C to the Order to the Claimants in the GLOBAL-365 Proceedings; and
- (ii) the Claimants in the GLOBAL-365 Proceedings shall disclose the categories of documents set out in Annex B to the Order to the Defendants;

(b) By 4 p.m. on 1 March 2024:

- (i) the Defendants shall disclose the categories of documents set out in Annex C to the Order to the Claimants in the Utilita Proceedings;
- (ii) the Claimants in the GLOBAL-365 Proceedings shall disclose the categories of documents set out in Annex B to the Order to the Claimants in the Utilita Proceedings; and

(iii) the Claimants in the Utilita Proceedings shall disclose the categories of documents set out in Annex A to the Order to all parties”.
