ORDER (RETURN/DESTRUCTION OF CONFIDENTIALITY RING DOCUMENTS)

PENAL NOTICE

TO MARIA PRUZHANSKAYA: IF YOU THE WITHIN-NAMED RESPONDENT DO NOT COMPLY WITH THIS ORDER YOU MAY BE HELD TO BE IN CONTEMPT OF COURT AND IMPRISONED OR FINED, OR YOUR ASSETS MAY BE SEIZED.

UPON the Competition Appeal Tribunal (the "**Tribunal**") ordering the establishment of a confidentiality ring (the "**Confidentiality Ring**") in these proceedings on 21 December 2021 (the "**Confidentiality Ring Order**")

AND UPON Ms. Maria Pruzhanskaya ("**Ms. Pruzhanskaya**") becoming a member of the Confidentiality Ring on 3 April 2023 by signing a personal undertaking on 24 March 2023 in the form annexed to the Confidentiality Ring Order (the "**Personal Undertaking**")

AND UPON Ms. Pruzhanskaya being loaned a Dell Vostro Laptop ([≫]) (the "Laptop") by the solicitors for the Class Representative inter alia for purposes of reviewing Relevant Documents containing Confidential Information (as per the definitions contained in the Confidentiality Ring Order)

AND UPON reading the application dated 5 March 2024 from the solicitors for the Class Representative pursuant to rules 68 and 69 of the CAT Rules 2015 (the "**Application**") and the evidence filed in support

AND UPON hearing Counsel for the Class Representative, Ms. Kirsty Malloch, Ms. Pruzhanskaya in person, and there being no attendance by or on behalf of any other party to the proceedings

IT IS ORDERED THAT:

- 1. Ms. Pruzhanskaya is made a party to these proceedings for the purposes of the Application and for the purposes of this Order.
- 2. Within 7 days of the date of service of this Order, Ms. Pruzhanskaya must deliver up to this Tribunal all equipment provided to her by the solicitors for the Class Representative, Maitland Walker LLP, including, but not limited to, the Laptop. For these purposes, delivery up is effect upon issue, by the Tribunal, of a signed document acknowledging receipt of the specific equipment (which must be itemised) delivered up by Ms. Pruzhanskaya.
- 3. Ms. Pruzhanskaya is enjoined from using Confidential Information in any way.

4. Within 7 days of the date of service of this order, Ms. Pruzhanskaya must file with the

Tribunal and serve on Maitland Walker LLP an affidavit confirming she has complied

with paragraph 7 of the Personal Undertaking. The affidavit must list all the equipment

she has delivered up to the Tribunal and confirm that this comprises all equipment

provided to her by the solicitors for the Class Representative.

5. The Class Representative's costs of and occasioned by this Application are to be paid

by Ms. Pruzhanskaya. Within 28 days of the date of service of this order, Ms.

Pruzhanskaya must make an interim payment of £10,000 on account to Maitland

Walker LLP. The remainder of the Class Representative's costs are to be subject to

detailed assessment, on the standard basis, if not agreed between the parties within 2

months of the date of service of this order.
