- 3. The Parties shall liaise and file an agreed electronic hearing bundle (including any authorities) and five hard copies, by 2pm on 7 May 2024.
- 4. Skeleton arguments be submitted electronically in Word, with a maximum limit of 20 pages (1.5 spacing and 12-point font); with
  - a. The Adur Claimants' skeleton to be submitted by 10am on 8 May 2024; and
  - b. The Defendants' skeleton to be submitted by 10am on 14 May 2024.
- 5. Costs in the case.
- 6. There be liberty to apply.
