**CONSENT ORDER**

---

**UPON** the Tribunal’s Order made and drawn on 24 March 2025 in the Epic Proceedings, the Coll Proceedings and the Rodger Proceedings (the **24 March 2025 Order**)

**AND UPON** the parties to the Rodger Proceedings agreeing to the terms of this Consent Order, without prejudice to any further variation to the following deadlines, including because the timetable to trial in these proceedings is subject to revision in light of the 24 March 2025 Order, which provides for joint case management of the Epic Proceedings, the Coll Proceedings and the Rodger Proceedings to trial commencing in October 2026

**AND HAVING REGARD TO** the Tribunal’s powers under the Competition Appeal Tribunal Rules 2015

**BY CONSENT IT IS ORDERED THAT:**

1. The 24 March 2025 Order is varied as follows:
  - a. Paragraph 6 is deleted and replaced with: “*The Defendants in the Rodger Proceedings (“Google”) are to serve their Defence by 4pm on 25 April 2025.*”
  - b. Paragraph 7 is deleted and replaced with “*The Claimant in the Rodger Proceedings is to serve his Reply by 4pm on 16 May 2025.*”

2. Costs in the case.
3. The parties to the Rodger Proceedings shall have liberty to apply in respect of this order.
