In accordance with Rule 111(1)(d) of the Competition Appeal Tribunal Rules 2015, the parties are authorised, if so agreed, to send or serve on each other any document required to be sent or served in the proceedings (including documents required to be sent to the Registrar for filing) by email to the email addresses set out in the Annex to this Order. All documents must be provided in a standard format (pdf, word, excel, txt) and the combined size of any email and its attachments must not exceed 25MB.
5. There shall be no order as to costs.
