- 1. By consent:

- 3. The proceedings in all three actions will be transferred to the Competition Appeal Tribunal pursuant to s. 16(4) of the Enterprise Act 2002 and para 8.3 of PD 30, on 31 July 2025.
- 4. The further CMC listed for week commencing 16 June 2025 is vacated.
- 5. Costs in the case.
- 6. There be liberty to apply.
