**ORDER (GOOGLE DISCLOSURE)**

---

**UPON** the confidentiality order dated 15 May 2024 (the "**Confidentiality Order**") providing, inter alia, for confidential information to be designated as Confidential Information or Legal Eyes Only Confidential Information (as those terms are defined in the Confidentiality Order)

**AND UPON** the Order of the Tribunal made and drawn on 20 December 2024 (the "**Directions Order**") following the case management conference on 18 and 19 November 2024 (the "**November CMC**"), giving directions for expert-led disclosure in Case No: 1589/5/7/23 (T)

(the “**Foundem Proceedings**”), Case No: 1424/5/7/21 (T) (the “**Kelkoo Proceedings**”), Case No: 1596/5/7/23 (the “**Ciao Proceedings**”), and Case No: 1636/5/7/24 (T) (the “**Connexity Proceedings**”) (the Foundem Proceedings, the Kelkoo Proceedings, the Ciao Proceedings and the Connexity Proceedings together the “**UK Shopping Proceedings**”) (the “**Expert-Led Disclosure Process**”)

**AND UPON** the Claimants’ and Defendants’ appointed experts for the First Trial meeting on a without prejudice basis in accordance with the Expert-Led Disclosure Process

**AND UPON** the Tribunal reviewing Google's application for disclosure and information in the UK Shopping Proceedings dated 19 June 2025

**AND UPON** the Tribunal hearing Counsel for the Claimants and Counsel for the Defendants at the hearing on 17 and 18 July 2025 (the “**July Hearing**”)

**IT IS ORDERED THAT:**

**A. DISCLOSURE BY THE CLAIMANTS**

**Kelkoo**

1. By 4pm on 1 August 2025, Kelkoo shall disclose and give inspection to the Defendants of all available data responsive to requests A27 and A29 in the Confidential Schedule to this Order.
2. Kelkoo shall provide a disclosure statement in respect of the disclosure ordered at paragraph 1 above by the same date.

**Connexity**

3. By 4pm on 1 August 2025, Connexity shall disclose and give inspection to the Defendants of all available data responsive to requests A27 and A29 in the Confidential Schedule to this Order
4. Connexity shall provide a disclosure statement in respect of the disclosure ordered at paragraph 3 above by the same date.

**Foundem**

5. By 4pm on 1 August 2025, Foundem shall provide a disclosure statement confirming that it does not hold any data or documents containing data that are responsive to A27 in the Confidential Schedule to this Order and/or that all such responsive data and documents have already been disclosed in the UK Shopping Proceedings.

**B. FURTHER MATTERS**

6. Documents and/or data containing Confidential Information or Legal Eyes Only Confidential Information which are disclosed by the Claimants shall be disclosed pursuant to the terms of the Confidentiality Order.
7. Costs in the case.
8. There be liberty to apply.
