ORDER (EXTENSION OF TIME)

UPON the Order of the Tribunal made on 1 August 2025 and drawn on 4 August 2025 giving directions (the “**Directions Order**”) providing, inter alia, that the parties file and serve factual witness statements by 4pm on 23 October 2025

AND UPON Foundem’s application dated 20 October 2025 to extend time to file and serve its factual witness statements to 4pm on 31 October 2025 (the “**Application**”)

AND UPON reading the Fifth Witness Statement of Thomas Robert George Bolster, filed in support of the Application, which at paragraph 9 confirmed “that Foundem agrees that neither

Foundem nor its advisors would receive or discuss the contents of Google's witness evidence with the other claimants prior to it being served by Google"

AND UPON reading the letter from Bristows LLP dated 21 October 2025 which contained the Defendants' response to the Application

IT IS ORDERED THAT:

1. The time for Foundem to file and serve its factual witness statements pursuant to paragraph 4 of the Directions Order shall be extended to **4pm on 27 October 2025**.
2. Google shall serve its factual witness statements produced pursuant to paragraph 4 of the Directions Order on Foundem by **4pm on 27 October 2025**.
3. Costs in the case.
