UPON the Order of the Tribunal made in the Epic, Coll and Rodger Proceedings on 4 August 2025

AND UPON the Order of the Tribunal made in the Epic, Coll and Rodger Proceedings on 27 August 2025

AND UPON the Order of the Tribunal made in the Epic, Coll and Rodger Proceedings on 15 December 2025

AND UPON reading Epic’s letter dated 16 December 2025 seeking an extension to the deadline for Ms Mc Call and Mr Hunt to file their economic expert reports (the “Application”)

AND UPON the parties consenting to the Application

IT IS ORDERED THAT:

1. Paragraph 19 of the Tribunal’s order dated 4 August 2025 (as amended by the Tribunal’s order dated 15 December 2025) shall be amended to read as follows (additions shown in underline):

“19.1 Save for the economic expert report of Professor Amelia Fletcher CBE, the economic expert report of Ms Iona Mc Call and the economic expert report of Mr Matt Hunt, by 5pm on 17 December 2025, Epic and the Rodger Class Representative shall file and serve their signed expert report(s) in the Epic and Rodger Proceedings in the fields and on the issues permitted by the Tribunal pursuant to paragraph 15 above

only.

19.2 By 5pm on 19 December 2025, Epic shall file and serve the signed expert reports of Ms Iona McCall and Mr Matt Hunt, in the fields and on the issues permitted by the Tribunal pursuant to paragraph 15 above only. By 5pm on 23 December 2025, the Rodger Class Representative shall file and serve the signed expert report of Professor Amelia Fletcher CBE in the fields and on the issues permitted by the Tribunal pursuant to paragraph 15 above only.”

2. Costs shall be costs in the case.

3. There be liberty to apply.
