**ORDER (PTR PROCEDURAL DIRECTIONS)**

---

**UPON** the Order of the Tribunal made on 1 August 2025 and drawn on 4 August 2025 (the "**Trial 1 Directions Order**") giving direction that a Pre-Trial Review ("**PTR**") be held during the window of 11 May 2026 to 22 May 2026 with a time estimate of one day

**AND UPON** the letter from the Tribunal dated 12 March 2026, listing the PTR for 21 May 2026 and requiring the parties to provide procedural directions for the PTR

**IT IS ORDERED THAT:**

**A. PROCEDURAL DIRECTIONS FOR THE PTR**

1. By **4pm** on **17 April 2026**, the Claimants shall serve a draft agenda for the PTR.
2. By **4pm** on **21 April 2026**, the Defendants shall serve their comments on the draft agenda provided.
3. By **4pm** on **23 April 2026**, the parties shall file and serve applications they propose to make at the PTR, if any, together with evidence, and the Claimants shall file a copy of the agreed agenda for the PTR. If the PTR agenda remains unagreed, the Claimants shall file an agenda for the PTR by this same time and date, indicating the extent of agreement and disagreement between the parties.

4. To the extent necessary, by **4pm** on **7 May 2026**, the parties shall file and serve evidence in response to any applications proposed to be made at the PTR.
5. By **4pm** on **8 May 2026**, the Claimants shall serve on the Defendants a draft index for the PTR bundle.
6. By **4pm** on **13 May 2026**, the Defendants shall serve on the Claimants a revised version of the index for the PTR bundle.
7. By **10am** on **15 May 2026**, the parties shall file and serve their skeleton arguments for the PTR (which shall include references to the electronic PTR bundle), together with a draft List of Headline Issues for Trial 1, if possible agreed, or indicating any issues which are not agreed.
8. By **4pm** on **15 May 2026**, the Claimants shall file an electronic version of the PTR bundle.
9. By **4pm** on **18 May 2026**, the parties will file and serve an updated agenda for the PTR agreed in correspondence.

**B. AMENDMENT TO THE TIMETABLE TO TRIAL 1**

10. The date set out in paragraph 12 of the Trial 1 Directions Order for the Claimants to file and serve the proposed timetable for Trial 1 is amended to **4pm** on **5 May 2026**.

11. Costs in cases.
12. There be liberty to apply.
