UPON the Judgment of the Tribunal dated 2 March 2026 [2026] CAT 15 concerning the Opt-In Issue

AND UPON the applications from the Mastercard Defendants and the Visa Defendants for their costs of the Opt-In Issue and the Opt-In Class Representative's response

AND UPON the Ruling of the Chair dated 29 April 2026 ([2026] CAT 39)

AND UPON the Mastercard Defendants and the Visa Defendants each filing a revised costs schedule on 6 May 2026

IT IS ORDERED THAT:

1. The Opt-In Class Representative shall pay the Mastercard Defendants' and the Visa Defendants' costs of the Opt-In Issue, to be subject to detailed assessment on the standard basis if not agreed.
2. The Opt-In Class Representative shall make a payment to the Mastercard Defendants on account of the costs payable pursuant to paragraph 1 above in the sum of **£194,989.11** (inclusive of VAT) by 4pm on **29** May 2026.
3. The Opt-In Class Representative shall make a payment to the Visa Defendants on account of the costs payable pursuant to paragraph 1 above in the sum of **£264,967.92** (inclusive of VAT) by 4pm on **29** May 2026.
