CONSENT ORDER

UPON the Tribunal's Order dated 4 August 2025 (the **4 August 2025 Order**) listing the trial in the Coll Proceedings and the Rodger Proceedings to commence on 28 September 2026 and making directions for the filing of skeleton arguments for trial

AND UPON the Tribunal's Order dated 31 July 2026 (the **PTR Order**) making directions in relation to the page limits applicable to skeleton arguments for trial.

AND UPON the Rodger Class Representative and Google having reached a settlement in principle and having made a joint application dated 25 August 2026 to the Tribunal for a collective settlement approval order (a **CSAO**) in respect of the Rodger Proceedings pursuant to Rule 94(3) of the Competition Appeal Tribunal Rules 2015 (the **CSAO Application**)

AND UPON the Tribunal's Order dated 26 August 2026 (the **CSAO Application Directions Order**) listing the CSAO Application for a hearing on 15 September 2026

AND UPON the solicitors for the Rodger Class Representative, the Coll Class Representative and Google having agreed to the terms of this Order

IT IS ORDERED BY CONSENT THAT:

1. Paragraph 33 of the 4 August 2025 Order is varied such that:
 - a. the Coll Class Representative shall file and serve her skeleton argument for trial on Google by **4pm on 11 September 2026**, and shall serve her skeleton argument for trial on the Rodger Class Representative by **4pm on 21 September 2026**; and
 - b. the Rodger Class Representative shall file and serve his skeleton argument for trial on Google and the Coll Class Representative by **4pm on 21 September 2026**.
2. Paragraph 34 of the 4 August 2025 Order is varied such that Google shall file and serve
 - (a) a skeleton argument for trial in relation to the Coll Proceedings on **4pm on 25 September 2026**; and
 - (b) a skeleton argument for trial in relation to the Rodger Proceedings on **4pm on 28 September 2026**.

3. Paragraph 19 of the PTR Order is varied such that the Google's skeleton arguments for trial shall comply with the following page limits (including any annexes):
 - a. Google's skeleton argument in relation to the Coll Proceedings shall not exceed 100 pages; and
 - b. Google's skeleton argument in relation to the Rodger Proceedings shall not exceed 50 pages.
4. The costs shall be costs in the case.
5. There be liberty to apply.
