- 1. The respondent file and serve its defence in each appeal in relation to the matters set out in the Schedule to this Order by 4.00pm on 14 December 2007
- 2. The interveners, if so advised, file and serve statements of intervention in relation to the matters set out in the Schedule to this Order by 4.00pm on 7 January 2008
- 3. The parties file and serve their written submissions for the hearing in a single, composite document by 4.00pm on 14 January 2008; the parties to liaise to avoid duplication of submissions
- 4. The parties prepare an agreed bundle of documents to serve as the main bundle for the hearing of the matters set out in the Schedule to this Order and an agreed bundle of authorities to be referred to at the hearing
- 5. The parties file ten copies of each of the said bundles by 12.00pm on 16 January 2008
- 6. A hearing to determine the matters set out in the Schedule to this Order be fixed for 10.30am on 24 January 2008 with a time estimate of 9 days
- 7. Costs be reserved
- 8. There be permission to apply
