## **VENUE**

1. The venue of the main hearing in these proceedings will be determined at a further case management conference

## **DISCLOSURE**

- 2. By 5pm on 31 October 2011, the Claimant disclose to the Defendant such documentation as is in its possession, which provides a summary description by the liquidator of the financial position of the company
- 3. By 5pm on 31 October 2011, the Defendant disclose to the Claimant:
  - a. those documents held on the OFT's file which were provided by the Defendant to the OFT during the course of the OFT's investigation
  - b. a list of the remaining documents held on the OFT's file which were provided by third parties to the OFT during the course of the OFT's investigation, redacted in a manner consistent with the OFT's treatment of confidential information in its Decision of 18 November 2008 and to the satisfaction of the OFT

#### WITNESS AND EXPERT EVIDENCE

- 4. In respect of such information disclosed pursuant to the OFT Disclosure Order and/or paragraph 3 above, the Claimant file and serve signed statements of any further witnesses of fact arising from such disclosure by 5pm on 30 November 2011
- 5. The April Order be varied by deleting paragraph 13 thereof and substituting the following text:
  - "13. As regards such expert evidence:
    - (a) The Claimant file and serve the statement of its expert witness by 5pm on 14 October 2011
    - (b) The Defendant file and serve the statement of its expert witness by 5pm on 4 November 2011
    - (c) Any joint statement prepared by the parties' expert witnesses be filed by 5pm on 13 January 2012"

## TIMETABLE TO HEARING

- 6. The April Order be varied as follows:
  - a. By substituting 20 January 2012 for 30 December 2011 in paragraph 15
  - b. By substituting 15 February 2012 for 3 February 2012 in paragraph 16
