ORDER

HAVING REGARD TO the Order of the President of 10 February 2016

AND UPON the parties having consented to the preliminary issue in these proceedings being heard jointly with the same issue in Case No 1240/5/7/15 (the “Joint Limitation Point Hearing”)

AND UPON the Joint Limitation Point Hearing having been listed for 29 April 2016

AND UPON reading the pleadings and material filed by the parties

AND HAVING REGARD TO the Tribunal's case management powers under Rule 53 of the Competition Appeal Tribunal Rules 2015 (S.I. 2015 No. 1648)

IT IS ORDERED THAT:

1. The wording for the preliminary issue to be determined in these proceedings is as follows:

On the assumption that foreign laws apply to the claims under section 47A of the Competition Act 1998 as alleged, whether the foreign rules relating to limitation apply in respect of those claims pursuant to section 1 of the Foreign Limitation Periods Act 1984.

2. The Claimants file three sets of an agreed indexed hard copy bundle by 5pm on 20 April 2016, and serve electronic versions of the bundle on the other parties by the same deadline.
3. There be filed on behalf of the Claimants by 5pm on 21 April 2016 an authorities bundle comprising the authorities relied on in this case and in Case No 1240/5/7/15, the contents of the bundle to be agreed by the parties in both cases.
4. The parties file and serve skeleton arguments by 5pm on 21 April 2016.
5. There be liberty to apply.
