ORDER

HAVING REGARD TO the Tribunal's Order of 12 January 2017 (the "**Directions Order**")

AND HAVING REGARD TO the Tribunal's powers under the Competition Appeal Tribunal Rules 2015 (the "**Tribunal Rules**")

AND UPON the letter of Hausfeld & Co. LLP dated 18 May 2017 sent on behalf of the Claimants and Defendants applying to vary the Directions Order

IT IS ORDERED BY CONSENT THAT:

1. Pursuant to paragraph 20 of the Directions Order the terms of the following paragraphs in the Directions Order are varied as set out below.

Witnesses of Fact

2. Paragraph 12 is varied such that each party will file and serve on every other party the witness statements of oral evidence which the party serving the witness statements intends to rely on in relation to any issue of fact to be decided at trial, such witness statements to be exchanged simultaneously, by 4pm on 23 June 2017.
3. Paragraph 13 is varied such that each party will file and serve on every other party any witness statements in reply by 4pm on 21 July 2017.

Expert Evidence

4. Paragraph 14 is varied such that the Claimants' expert shall file and serve a report in relation to the matters set out in paragraph 13 of the Order dated 11 October 2016 by 4pm on 1 September 2017.
5. Paragraph 15 is varied such that the Defendants' experts shall file and serve their reports in response, but will liaise to avoid any unnecessary duplication, by 4pm on 13 October 2017.
6. Paragraph 16 is varied such that the Claimants' expert shall file and serve a reply report by 4pm on 10 November 2017.
7. Paragraph 17 is varied such that by no later than 4pm on 24 November 2017 the parties' experts shall meet in accordance with paragraph 16 of the Order dated 11 October 2016 and shall identify in a joint memorandum the matters set out at paragraphs 16 (a) – (c) of that Order.
8. Paragraph 18(b) is varied such that the parties' experts shall file with the Tribunal a short progress report (in the form set out in that sub-paragraph) by 4pm on 17 November 2017.

Costs

9. Costs in the case.
10. There be liberty to apply.
