ORDER

**UPON** reading the Application dated 7 December 2018 of the 10<sup>th</sup> Third Party in the VSW Claims, the 5<sup>th</sup> and 6<sup>th</sup> Defendant in the Dawsongroup Claim, and the 10<sup>th</sup> and 11<sup>th</sup> Defendants in the Ryder Claim (together, "**Daimler**") and the 2nd Witness Statement of Mr. Boris Bronfentrinker dated 8 December 2018

**AND UPON** the following definitions applying for the purposes of this order:

The "**DAF Decision Addressees**" has the same meaning as in the Orders of the Tribunal

The "**Dawsongroup Claim**" means Claim 1295/5/7/18 (T)

The "**Orders of the Tribunal**" means the orders made by the Tribunal in the Dawsongroup Claim, the Ryder Claim and the VSW Claims at the case management conference of 21 and 22 November 2018

The "**Ryder Claim**" means Claim 1291/5/7/18(T)

The "**VSW Claims**" means Claim 1292/5/7/18 (T), Claim 1293/5/7/18 (T) and Claim 1294/5/7/18(T)

**IT IS ORDERED THAT:**

1. Daimler's Application is to be heard on 16 January 2019.
2. Pending the hearing of the Application, the DAF Decision Addressees shall not disclose the documents referred to in the Annexes to the said witness statement of Mr. Bronfentrinker.
3. Paragraphs 2, 12 and 18(b) of the Orders made on 19 December 2018 in, respectively, the Dawsongroup Claim, the Ryder Claim and the VSW Claims are varied accordingly.
