**IT IS ORDERED BY CONSENT THAT:**

1. The time for compliance by the First, Second, Third, Fourth, Eleventh and Twelfth Proposed Defendants with paragraph 8 of the Directions Order is extended to 4pm on 6 December 2019.
2. The time for compliance by the Fifth and Sixth Proposed Defendants with:
  - (a) Paragraph 8(a) of the Directions Order, to the extent any contracts satisfying the criteria at paragraph 8 of the Directions Order are available and ready to be disclosed; and
  - (b) Paragraph 8(b)(ii) of the Directions Order,is extended to 4pm on 6 December 2019.
3. The time for compliance by the Fifth and Sixth Proposed Defendants with:
  - (a) Paragraph 8(a) of the Direction Order, in respect of the remaining contracts not disclosed pursuant to sub-paragraph 2(a) above; and
  - (b) Paragraph 8(b)(i) of the Directions Order,is extended to 4pm on 11 December 2019.
