CONSENT ORDER

UPON the Order of the Tribunal made in these proceedings on 19-20 September 2019 (**Disclosure Order**), in particular paragraph 6(b) which directed Volvo/Renault to disclose by list documents and/or Data responsive to the O4A, DG O1, DG O2, DG O3, DG O4B, DG O4C, DG O5D and DG O6 categories identified in Annex 3 to that Order

AND UPON the Consent Order made on 6 March 2020 ordering that Volvo/Renault’s disclosure of the documents referred to in paragraph 6(b) of the Disclosure Order be extended to 30 April 2020

AND UPON the Consent Order made on 27 April 2020 ordering that Volvo/Renault’s disclosure of the documents referred to in paragraph 6(b) of the Disclosure Order be further extended to 4 June 2020

AND UPON the application by Volvo/Renault by their solicitors’ letter dated 1 June 2020 further to extend the time for certain disclosure by reason of the difficulties caused by the Covid-19 pandemic, which application is agreed to by the Claimants

AND UPON the definitions adopted in the Disclosure Order applying for the purposes of this Order, except where otherwise stated, and the following definition applying for the purposes of this Order:

- the “**Remaining Categories**” means categories O4A, DG O3, DG O4B, DG O4C and subsection (d) of DG O6 identified in Annex 3 to the Disclosure Order

BY CONSENT IT IS ORDERED THAT:

1. The time for Volvo/Renault’s disclosure of data/documents referred to in paragraph 6(b) of the Disclosure Order responsive to the Remaining Categories be extended to 10 July 2020.
2. Costs in the case.
3. There be liberty to apply.
